TERMS AND CONDITIONS

1.0 CAMPAIGN/PROMOTION PERIOD:

This Campaign is organised by AEON Credit Service (M) Berhad ("AEON Credit") and will commence from 05 January 2026 to 31 March 2026 ("Campaign Period").

2.0 ELIGIBILITY CRITERIA:

2.1 This Campaign is open exclusively to Principal and Supplementary Cardholders of AEON Member Plus (AMP) Platinum, Gold, and Classic Visa/MasterCard Credit Card, including both Physical and Virtual Cards ("Eligible Cardholders").

2.2 The following persons are NOT eligible to participate in this Campaign:

- Employees of AEON Credit, advertising agencies and Campaign service providers of AEON Credit (including its affiliated, related companies and their immediate family members) directly involved/related to this Campaign.
- Any cardholder whose account is not in order, who has committed or is suspected of committing any misconduct, fraudulent or wrongful acts in relation to their account(s), any facility, service or accommodation granted by AEON Credit.

3.0 QUALIFYING CONDITIONS:

3.3 This Campaign is not applicable to disputed transactions, 0% Instalment Payment Plans, Flexi Payment Plans, Cash Advances, Balance Transfers, late payment charges, reversals, and other fees and charges.

3.4 Transactions made by the Supplementary Cardholders will be counted as the Principal Cardholder's spendings. Only the Principal Cardholder will be entitled to entry(ies).

4.0 REWARD REQUIREMENTS

4.1 To participate in this Campaign, Eligible Cardholders are required to spend using their AEON Member Plus (AMP) Credit Card to qualify for the Prizes. (*hereinafter referred to as 'Reward'*)

5.0 SELECTION OF WINNERS / FULFILLMENT OF REWARD

5.1 Winners of this Campaign will be shortlisted within 15 days after Campaign Period ends. The Winners will be shortlisted through a system-generated random draw.

5.2 For the avoidance of doubt, each Eligible Cardholder may win only one (1) prize across all prize categories in this campaign.

a) Grand Prize (Supermarket Sweep)
